Dear Ferry Vessel Operators:

Thank you for your continued support of the annual U.S. Navy and City of San Francisco sponsored Fleet Week Parade of Navy Ships and Navy Blue Angels flight demonstrations to be held from October 10, 2024, through October 13, 2024. To ensure the safety of participants and spectators on the navigable waters of San Francisco Bay, the Coast Guard has enacted the special local regulation, which is published in 33 CFR §100.1105. In addition to this notice in the *Federal Register*, the Coast Guard will provide the maritime community with extensive advance notification of this enforcement period via Local Notice to Mariners and Broadcast Notice to Mariners. Coast Guard enforcement personnel, Coast Guard Auxiliary, the San Francisco Police Department, and other law enforcement vessels will be patrolling the regulated areas to preserve public safety and to ensure that all Fleet Week events are conducted safely.

Provided is chart 1 for the regulated area "Alpha" for the Navy Parade of Ships, which will be held on Friday, October 11, 2024, from 10 a.m. to 12 p.m. Traffic will be restricted by a special local regulation throughout most of the Central San Francisco Bay from the Golden Gate Bridge, south of Alcatraz, to just south of the San Francisco-Oakland Bay Bridge. This is to accommodate the Navy Parade of Ships as the ships pass under the Golden Gate Bridge to their assigned moorings in San Francisco, CA. No vessel will be permitted to cross the parade line or interfere with the safe transit of the parade participants in any way. A 100-yard protective zone will also be enforced around each naval vessel during the entire time they are in the port.

Provided is chart 2 for the regulated area "Bravo" for the U.S. Navy Blue Angels Activities. Federal Aviation Administration regulations require that this area is clear of all persons and vessels during the specified times to provide an unobstructed ditch zone for demonstration aircraft. The area depicted on the attached chart will be closed from Thursday, October 10th, through Sunday, October 13th, 2024. Ferry Vessels are not to operate or transit within area "Bravo" during the following periods to accommodate the Navy Blue Angels Activities:

Thursday, October 10 th	12:00 p.m. to 5:00 p.m.
Friday, October 11 th	12:00 p.m. to 5:00 p.m.
Saturday, October 12 th	12:00 p.m. to 5:00 p.m.
Sunday, October 13 th	12:00 p.m. to 5:00 p.m.

Vessels requesting permission to transit through the safety zone may request authorization to do so from the Patrol Commander (PATCOM). The PATCOM may be contacted on VHF-FM Channel 23. Vessel operators may also contact Coast Guard Vessel Traffic Service (VTS) at (415) 556-2760, (415) 399-7410, or on VHF-FM Channel 14 (156.7 MHz).




